Preparation:

1. EFT Intensive attendees will make a video of a live session and then select the segment (30-45 minutes) that you want us to review live at the training. **You must get a signed release form from your client prior to taping.**
2. At the conclusion of the session, you will ask the client to complete a **client feedback form.** (That will come to me and I will share that information at the conclusion of your evaluation.)
3. EFT Intensive attendees will bring their video to the EFT Intensive training on either **a) a DVD, b) your FlipCam, or c) a thumb drive** so that I can play the video through my laptop the projector.
4. You must submit a **written case study** at least 48 hours before the EFT Intensive training so that I can make copies of it for the group.

The Presentation:

- Each practitioner will take 5-10 minutes introducing their video and highlighting the case study points.
- We will all watch the video and score the practitioner using an **evaluation form.**
- After the video review we will have time to ask questions and give feedback.
- Finally, I will share the feedback form from the actual client.
- I will then collect the scoring sheets. (I have not yet decided if I will give them to the practitioner then, or if I will make copies of them for your record first.)
